**Re:    Draft Nunavut Land Use Plan Meeting Request**

The Nunavut Planning Commission was established under the Nunavut Land Claims Agreement (NLCA) to develop and implement land use plans that guide and direct resource use and development in the Nunavut Settlement Area. As stated in Article 11 of the NLCA, the Commission shall give great weight to the views of communities in the development of land use plans. In the past we worked closely with your community during the development of the Keewatin Regional Land Use Plan, which we currently implement. Since 2007, the Commission has been developing a Draft Nunavut Land Use Plan, which was provided to you in September 2012. Once approved, the Nunavut Land Use Plan will replace the Keewatin Regional Land Use Plan.

The Commission will be visiting all 25 Nunavut municipalities over the next two years to discuss the Draft Nunavut Land Use Plan. We will be in your community on November 21 -22, 2013, and in addition to the public workshops and information sessions we will be hosting, the Commission would greatly appreciate the opportunity to meet with your Hamlet Council during our visit. We are interested to know if you will be available for an audience at 9:30 AM on November 21, 2013 in the Council chambers. During the meeting, we will provide the Council with an overview of the Draft Plan, discuss any questions in this regard, and listen to your feedback.

We hope that the members of your Council will be able to meet with us to discuss how the Draft Nunavut Land Use Plan should guide and direct future land and resource use and development in

Nunavut. As the Commission's Chairperson, I will be attending the meeting, along with the Commission Executive Director, Sharon Ehaloak and James Eetoolook, who is our facilitator for the community workshops. Commission staff will also be present to discuss the plan and record feedback.

If you are available to meet with us, we will also invite the local Hunters and Trappers Organization, Community Lands and Resources Committee, and appropriate Members of the Legislative Assembly.

We look forward to hearing from you regarding your availability to meet with us at 9:30 AM on November 21, 2013.
