I scheduled follow up phone call for Aug. 24.

They want O&G moratorium lifted; want a Territorial Park but don't want it to restrict access to oil and gas development; want royalties from mining (get NAM resolution); doing a community ecotourism plan (due Sept); geoscience mapping occurring; good carving stone and gravel extraction potential (85% of the island is gravel); need to increase employment and economic revenues; old contaminate army sites need cleanup; interested in commercial fishing licence; want to understand commercial caribou harvests better (economic potential). Need better understanding of planning process and what it will and will not address. I promised to follow up with email/letter confirming discussions and providing more background/info on planning (requested English and Inuktitut).
Aug. 27/07	Ronald Ladd & Louisa Kudluk	Hamlet of Coral Harbour	Sent email confirming content of discussions, providing background on plan issues, and requested backup documents (letter and reports) relating to topics of discussion.
Aug. 28/07	Wayne Horsman	EDO, Hamlet of Cambridge Bay	Wayne came by to get map of carving stone locations from Mike. I discussed Plan development briefly with him and told him about the request for input that went out to communities. I forwarded the letter to him in follow-up, which he passed on to Tara Rutherford. Wayne is interested in advancing the carving industry in the Kitikmeot from quarry to market. He is in discussion with KIA and other parties to move this forward and is building a funding proposal. This is in line with the GN Carving Stone Action Plan. He wants a carving centre set up in Cambridge Bay. He talked about the project done in Labrador with great success. I told him about Coral Harbour's interest and forwarded him the SAO's contact info. Cam Bay's other key focus right now is in participating in the IIBA negotiations with Zinifex for the High Lake Project. The mayor negotiated a seat at the table for them to advance community issues. Wayne/Tara followed up to say the letter is going to their lands committee for input. Tara will let me know when the meeting will be held.
Aug. 30/07	Ronald Ladd	Hamlet of Coral Harbour	Received Feasibility Plan for Alijivik Park by email, and NAM Resolution and Cover Letter for the Park Plan by Fax from Ronald.
Aug. 31/07	Ronald Ladd	Hamlet of Coral Harbour	Received by fax a copy of letter from NPC to Minister of NRCAN from Feb. 23/06 RE removing moratorium on oil and gas from Southampton Island.
Sept. 4/07	Ronald Ladd	Hamlet of Coral Harbour	Email received requesting clarification on when the oil and gas moratorium would be lifted. He cc'd Patterk Netser, MLA (and Minister). Forwarded to Adrian for response.
Sept. 24/07	Derrick Anderson & Tara Sutherland	Hamlet of Cambridge Bay	Tara emailed on Sept. 19/07 to say there was confusion about what types of issues we were looking for. We set up a meeting to discuss it a bit more. I explained the planning process and what we were after. The key points of discussion were: 1) Cambridge Bay's municipal boundary is very large so most issues affecting the community occur on lands within their control.

			<p>2) There is interest in soapstone quarrying as per our discussions with their EDO Wayne Horsman.</p> <p>3) Establishment of new fish camps or tourism operations for sport or commercial fishing: The hamlet wants to make sure they are done right and that they are cleaned up afterwards. Currently operators use the town dump to dispose of fish guts which attracts unwanted wildlife.</p> <p>4) Miramar wants to use the community dump for their operations. This overloads public infrastructure.</p> <p>5) Miramar also wants to use the dump for contaminated soil. Cambridge Bay doesn't have a land farm area. The hamlet is okay with them putting some of the soil in barrels and taking it to the dump, but large quantities should be sent to Swan Hills for proper disposal.</p> <p>6) Cabins: Discussion about need for leases for non-Inuit to build cabins. No one applies for them. If they are outside the surveyed area then its Commissioner's land and application should be made with CGS. The hamlet doesn't necessarily want leases issued. The issue is that there are no controls on where cabins are built in hinterland areas. These are all within municipal boundaries right now but if the hamlet decides to put controls in place, some people may choose to built cabins outside municipal areas. This could become a planning issue for us.</p> <p>7) Tourism: Katiga and Ferguson Lakes are popular for fishing (commercial and tourism). They are outside community boundary.</p> <p>8) Hamlet continually loses staff to the mines. They go through the time and expense to train sewage and water truck drivers and then they lose them to the mines.</p> <p>9) Cambridge Bay is in the process of updating their community plan (Aarluk Consulting). The current version is from 1996/97.</p> <p>I emailed notes to Tara and Derrick to confirm points on Sept. 25/07. Tara confirmed their accuracy by email on Sept. 26/07.</p>

The response described NPC's plans for NLUP development in which the amendment could be brought forward and the past and current challenges with the GN that are holding up the plan development process.

			<p>Qavvik will be acting. Thomas recommended I brief Sam a few days before the next meeting so he can raise the issue and get feedback. Sam can be reached at (867) 266-7908.</p> <p>I gave Thomas a brief overview of what types of issues land use plans address. He stated that he has only been there 6 months but the ecosystem and environment are big priorities for the community. There is a lot of concern about the effects of water diversions in James Bay on the community's livelihood; impacts on the environment, sea mammals, seal, beluga, geese, ducks, country foods that people depend on. Also impacts with climate change on these animals. He suggested I contact the hamlet's Special Projects and Environmental Coordinator in Winnipeg – Miriam Fleming (204) 257-9061. She has worked with them since the '90s and can give a lot more information.</p> <p>For economic development, there is a focus on docks and harbours, cleanup of the shoreline, soapstone quarrying (some last year, no money this year, more next year), some small businesses (coop and hotel, internet service, arts and crafts) but not much. No industry (mining, oil and gas or tourism). It's an island so nothing close. It's a big rock and they sit on top of it! Mostly a wage economy. The hamlet is the major employer, businesses. Population is about 800 people. They also have drug and alcohol issues (he called it an industry – bootlegging).</p>

I summarized the discussions by email afterwards as per below and attached our NLUP Scoping Document to explain our process.</p> <p>Iqaluit identified the following potential land uses outside it's community boundaries that are important for the community:</p> <ul style="list-style-type: none"> • Gravel sources for future development • Need for a future landfill site • Alternate water source • Room for expansion (e.g. more housing). The population is expected to double in the next 20 years and they need to make sure they have adequate room for this within their municipal boundaries. • Development of a deep water seaport (Nanisivik and Resolute). While the city is not directly involved in the development, this will create great economic benefits for Iqaluit. • Interest in building a small harbor craft port / ramp

			<p>Iqaluit is initiating a community sustainability plan. It will take a year or two. It will identify a lot of the broader issues we look at in regional and territorial land use planning so will provide good guidance for us once it is complete.</p> <p>The GN is developing an Energy Strategy and that will be an important initiative for communities and will provide direction for us.</p> <p>Similarly, the emphasis on mineral exploration and development will impact Iqaluit as the supply centre for such activities, especially with respect to Iqaluit's infrastructure.</p> <p>A final issue raised was cleanup of metal dumps. There was a large accumulation of metal in Iqaluit long before it was a city. The US Government buried their vehicles when they left and they are becoming exposed now. No one is taking responsibility for it. Iqaluit can't afford to clean it up. It can affect the land and water (metal corroding and contaminating the ground). There is more metal coming in all the time as people buy more vehicles but no way to get rid of it. John asked how other communities deal with it. He sees this as an INAC contaminants issue.</p> <p>Sent notes by email and Isabel confirmed. I asked if specific locations were known for future gravel, water and landfill sites. She referred me to Michelle Bertol. Need to follow up with Michelle.</p>
Oct. 25/07	Joeli Qamanirq	Hamlet of Arctic Bay	<p>Community call. He didn't have a chance to talk to the mayor about it yet. He asked me to resend the letter to him and he would forward it on to the mayor for discussion (done). I will check back with him next week.</p>
Oct. 25/07	Art Stewart	Hamlet of Cape Dorset	<p>Community call. I explained the process and what we're looking for. He'll take the letter to council for further discussion and offered the following points to begin:</p> <ul style="list-style-type: none"> • Cape Dorset is on a small island, surrounded on 3 sides by water with the mainland on the other side. • She are expecting mineral exploration to pick up soon. They found kimberlite deposits last year, as well as iron ore, copper, gemstone (jade or whatever was found near Kimmirut). • There have been no major developments or environmental assessments affecting the community so there are few issues to raise. • Cape Dorset will be doing a community plan soon that will look at some land use outside community boundaries. • There is a park on Mallik Island (?). The community wants to preserve traditional sites like tent rings. • One suggestion that has been raised is the need to build some make-shift camps out on the land to keep people safe when get lost or turned around. Search and rescue has been very busy lately.

Right now their only connection is a small land bridge that is not passable. Oct. 31/07	Miriam Fleming	Hamlet of Sanikiluaq	<p>Miriam called in response to voicemail and email I sent on Oct. 30. We discussed the community's work to identify impacts on the marine environment from hydro development for about an hour. I emailed her my notes following the call for confirmation. The points I took are:</p> <ul style="list-style-type: none"> • She lived and worked in Sanikiluaq from 1986 – 2005 and continue to work for the hamlet from Winnipeg. • The key issue for the community is the marine environment, and specifically, the downstream effects from hydro development. The community has been working on this since 1990. • A cumulative effects assessment on human activity in Hudson Bay was conducted involving 28 communities from Hudson Bay, James Bay and Foxe Basin. It included traditional ecological knowledge. Hunters had noticed a change in the sea ice, seals and eider ducks since the 1970s when the first stage of the James Bay project went into commission (she mentioned she would send a copy of the study). In the early 1990s, there was a volcano eruption in the Phillipines resulting in cooler air temperatures. Hunters from Sanikiluaq, Kimmirut and other communities noticed that the water currents were weakening and more sea ice was forming.

			<p>There was a massive die-off of Eider ducks on the Belcher Islands. The study was done at this time so picked up on these changes.</p> <ul style="list-style-type: none"> • Between 2000 and 2005 there were warmer air temperatures, the ice was thinner, and hunters noticed more freshwater in the sea ice and changes in the seals. Hunters were monitoring seal stomach contents and body condition and noticed these were deteriorating. • The hydro issue came back in 2002. There is a new hydro project going through the review process now (Eastmain 1A and Rupert Diversion). The Nunavut-Hudson Bay Interagency Working Group (NTK) commissioned a scientific report on the effects of hydro-electric development on sea ice for this review. It validates the hunters' observations and identified a masking effect. There is an influx of freshwater in the winter months which pools in Hudson Bay and makes the Belcher Islands a hotspot (Question: What did you mean by this?) Information related to the project and working group are available at www.geoarctic.com/sanikiluaq (I found the site). The book "Voices from the Bay" provides a good overview of hydro development and effects. (I found a copy of it in the office here.) • The concerns are now about the effects of hydro development and climate change in combination. • There is a long-term resource development agreement signed between Quebec and the James Bay Cree regarding different types of resource development including hydro. QIA, NTI, KIA and affected NU municipalities are also included in the agreement. (Please forward the link.) • Previous studies always stopped at the mouths of rivers so Sanikiluaq was left out. • When she was the Community Economic Development Officer she produced a Community Economic Development Strategy. It was done in 2000 and has not been updated since so may be out of date. In the 1990s the community did a Tourism Development Plan for the Belcher Islands which identified sites for tourism. We could request a copy of these from the hamlet and use these documents as a basis for discussions with the community to see what is still valid. • Historically, the community did not want mining in the Belcher Islands. Inuit hold the subsurface rights to the island. QIA (John Amagoalik) was recently holding discussions with the community to see if that decision (no mining) still holds true. We can talk to QIA to find out how discussions went. • She expressed the need to protect the Belcher Islands for research and monitoring for ecological reasons. It's a unique environment because of the relationship to the marine environment. • She mentioned that planning is not consistent with the Inuit way. They do not want to create boundaries and zones. The natural environment sets those. They prefer to promote traditional practices and codes of conduct, not zones.
