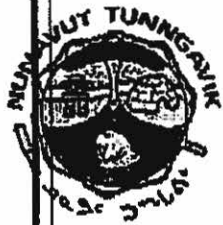

Re: Nunavut Land Use Plan

Thank you for your letter dated September 30, 2009. In this letter you provide us with an update of your land use planning activities and future plans. You also ask if NTI has additional data or information for the NPC, and if NTI has established goals and objectives for Inuit Owned Lands.

We look forward to participating in the technical panels to review in detail the data and information that constitutes NPC's "baseline knowledge". The technical panels will assist in identifying any substantial data or information gaps.

Management and administration of Inuit Owned Lands is a responsibility shared by NTI and the Regional Inuit Associations. From NTI's perspective, Inuit goals and objectives for Inuit Owned Lands are for the most part stated in Article 17 of the NLCA, NTI's Bylaws and approved land and resource related policies. The Claim and NTI's Bylaws, and approved policies including the Rules and Procedures for the Management of Inuit Owned Lands state the primary purpose, characteristics, guiding principles, goals and objectives, policy statements, and procedures concerning Inuit Owned Lands. If you would like a copy of these documents, please let us know.

NTI remains committed to assisting the NPC in the development of a Land Use Plan for the Nunavut Settlement Area by February 2011 as directed by your

Commissioners. NTI will continue working with the planning partners, including participating in community level consultations as they arise.
