



NUNAVUT PLANNING COMMISSION REVISED NOTICE OF NEXT STEPS FOR REGIONAL PUBLIC HEARINGS ON 2021 DRAFT NUNAVUT LAND-USE PLAN

Date: March 28, 2022

On October 21, 2021 the Nunavut Planning Commission (NPC or Commission) postponed the Regional Public Hearings in respect of the 2021 DNLUP that were originally scheduled for November 2021 to March 2022 to provide all participants adequate time to review materials in Inuktitut, English or French. As a result of the most recent Covid-19 outbreak in Nunavut in January 2022, the Commission further postponed the regional public hearings to the fall of 2022. Due to the recent easing of travel restrictions and changes to public health measures across Nunavut allowing for public gatherings, the NPC has decided to proceed with its plans to hold in-person public hearings in the Kitikmeot, Kivalliq, Qikiqtaaluk (North/South Baffin, Nunavik) Regions, and for affected Dēnesūliné communities in September to November 2022. **The Qikiqtaaluk hearings remain subject to the availability of funding.** Refer to Appendix A for further updates regarding logistics arrangements for the Public Hearings.

1. IMPORTANT DATES

The table below shows the new dates and venue locations for the upcoming regional public hearings. Parties should be aware that the dates set below for the public hearings may change depending on public health orders that is in effect at that time. Should the Commission decide to make any changes to the timetable of events, these will be communicated to participants through a procedural update.

The Public Hearings will provide a public forum for discussion of those technical issues that have been identified on the 2021 DNLUP and which remain unresolved, as well as issues for which there is public concern and other matters considered relevant to the NPC's development of the Nunavut Land Use Plan.

2. PARTICIPANTS AND EXTENDED TIMELINES FOR ADDITIONAL WRITTEN SUBMISSIONS

Parties not yet registered as participants are able to do so by completing the registration form in **Appendix B**, as soon as possible.

Furthermore, participants who have already provided written comments in the last round of comment request in 2021 are able to provide additional comments, and other participants are now requested to provide any additional written submissions by **April 15, 2022**. As previously stated, participants should be aware that this is an opportunity to:

- Provide any additional comments and opinions about the 2021 DNLUP that were not previously submitted in the last round of comments in 2021;
- Present arguments about the relevance and weight of any evidence that is before the Commission regarding the 2021 DNLUP; and
- Make your recommendation on which components of the 2021 DNLUP should be changed or approved and if so, under what conditions.

As previously noted, the consultation record for the 2021 DNLUP will close 40 days after the conclusion of the final regional hearing.

3. AVAILABILITY OF DNLUP DOCUMENTS AND ACCESS TO INFORMATION

Copies of the 2021 DNLUP and Options and Recommendations document and all submissions filed in the NPC's public record in association with the DNLUP are available online at: <http://lupit.nunavut.ca/portal/registry.php>. The Interactive maps and GIS files of the maps are available on the NPC's website at www.nunavut.ca.

Hard copies of 2021 DNLUP and Options and Recommendations and the executive summary documents have been sent to the Municipal offices in each community. HTOs are asked to visit the Municipal office to pick up copies if they have not yet received them.

4. NPC DIRECT ENGAGEMENT WITH PARTICIPANTS

NPC staff are available and remain committed to meet with participants to provide an overview of the DNLUP or to respond to any clarifying questions to assist with the preparation of written submissions on or before **April 15, 2022**.

Over the course of the first quarter of 2022, NPC staff have met with representatives from the following organizations: the Government of Nunavut, DeBeers, the World Wildlife Fund (WWF), the Nunavut Water Board (NWB), the Kivalliq Inuit Association, the Dënesųłiné communities and several departments of the Government of Canada. Additional meetings with the Government of Canada, the Government of Nunavut, NTI & RIAs, and industry are being scheduled for the coming weeks and the Commission encourages other participants to engage with NPC staff to discuss any outstanding technical issues prior to the Public Hearings.

5. NPC COMMUNITY INFORMATION AND PREPARATORY SESSIONS

The NPC has decided to proceed with its plans to conduct in-person information and preparatory sessions for community representatives based in the Kitikmeot, Kivalliq and Qikiqtaaluk (North/South Baffin) Regions in advance of the Regional Public Hearings with the following schedule and timelines:

- Kitikmeot Region = April 25-29, 2022
- Kivalliq Region = April 25-May 4, 2022
- Dënesųłiné communities = Dates to be determined
- Qikiqtaaluk (South Baffin) = June 2022
- Qikiqtaaluk (North Baffin) = June 2022
- Nunavik communities = Dates to be determined

The Qikiqtaaluk community visits are subject to the availability of funding. The NPC will be sending letters of invitation for each community to select **five (5) representatives** to attend and participate in the upcoming information and preparatory sessions.

Please note that community organizations have until **April 8, 2022 (Kitikmeot/Kivalliq) and May 13, 2022 (Qikiqtaaluk)** to appoint their representatives and to send details of the representatives to the NPC office at submissions@nunavut.ca.

6. MEDIA ACCESS

The NPC requests that all media organizations that wish to record proceedings during the Public Hearing (film, photograph, audio) request media access from the Commission on or before **August 12, 2022**.

NPC PUBLIC HEARINGS LOGISTICS AND ARRANGEMENTS

The Commission has made the following logistical arrangements for the upcoming Public Hearings in Nunavut and Thompson, Manitoba.

a) PARTICIPATION AND FORMAT OF HEARING

Participants can attend any of the regional hearings in person and will be able to observe the hearings online through live streaming. **Interactive virtual participation will not be possible.** Parties intending to participate in the public hearings must register by contacting the NPC least 30 calendar days in advance of the start of the public hearings. Early registration will allow for the public hearing sessions and agenda to be planned in a logical and organized manner.

b) INTERPRETATION SUPPORT

All proceedings will be open to the public and media and will be conducted with simultaneous English-Inuktitut-French-Dënesųliné interpretation.

c) SEATING ARRANGEMENT AND COVID-19 PROTOCOL

Seating will be assigned at each location based on the number of parties registered to attend in each location. Please note that in-person meeting sites will be managed in accordance with Public Health Orders in place for each location. All participants attending in person should be aware that full vaccination and non-medical face masks will be mandatory for attendance.

d) PUBLIC HEARING FACILITATOR

Please note that the public hearing proceedings will be facilitated by the NPC Chairperson.
