A brief summary of the reasons for our interest in the proceeding including the information, knowledge or views we possess that would be useful for the resolution of a matter before the NPC


Since the submission of our letter dated May 16, 2016 as interested parties in this matter we believe the concerns set out in our correspondence suggest information, knowledge and a type of understanding that is not able to be brought by other parties of the conflict that exists between harvest restrictions that have been imposed on the Bluenose East (BNE) caribou in the Northwest Territories at the same time that permits were being approved for exploration by Tundra Copper in the BNE core calving grounds and migration route. Specifically, the calving grounds are threatened as the BNE caribou pass through our traditional territory and being able to provide the Commission with our perspective to assist in its decision making process at this critical time provide the basis for our desire to be granted standing as Participants to the Nunavut Planning Commission's hearing.

The nature and scope of our intended application – will we be making an oral or written submission and is there a particular issue we are interested in.


We will be making written submissions.

The particular issue we are interested in raising concerns are in regards to our suggestion that we continue to view a firm prohibition on industrial activity in core calving grounds and key access corridors with restrictions in post calving areas are the paramount means which will shield BNE caribou populations.


