Kitikmeot Mayors Meeting Resolutions – September 18-20, 2018

Resolution # 2018 - 6 Subject – Nunavut Planning Commission Public Hearing Process

Whereas; the sole source of funding for the Nunavut Planning Commission is from the Government of Canada we direct the Government of Nunavut to support the Kitikmeot Mayors demand that adequate funding be provided so the voices of the Kitikmeot are heard as per Section 11 part 5 of the Nunavut Agreement to share and voice our concerns during the 2016 Draft Nunavut Land Use Planning process prior to the commission re-drafting as outlined in the Nunavut Agreement;

Therefore, be it resolved that; the Kitikmeot Mayors direct the Government of Nunavut to support the Nunavut Planning Commission to complete the Kitikmeot and Kivalliq Public Hearings so that the communities' voices are heard and included in the 2016 Draft Nunavut Land Use Planning process and done prior to the Commission re-drafting the 2016 Draft Nunavut Land Use Plan, but failing adequate funding the Kitikmeot Mayors request the Nunavut Planning Commission to conclude its work with the information gathered and submit the Commissioners revised Plan for Ministerial Approval even in the absence of further public hearings.
