Background: The Nunavut Planning Commission has been consulting publicly on the Draft Nunavut Land Use Plan (DNLUP) since October 2012.

Purpose: The DNLUP is nearing completion. One of the remaining challenges of the land use planning process is to ensure that subsequent submissions from the planning partners address the key remaining gaps in the DNLUP. This workshop is intended to:

- update planning partners on the current status of the DNLUP;
- to explain why the DNLUP is taking the form it is and to explain the decision-making processes used to strike a balance between sometimes conflicting recommendations from the planning partners in part through reviewing the decision making structure set out in the Options and Recommendations Document; and,
- to request of planning partners information required to complete the first generation Nunavut Land Use Plan.
