**Re: Nunavut Wildlife Management Board application for standing at the Nunavut Planning Commission public hearing on the draft Nunavut Land Use Plan**

Thank you for providing the Nunavut Wildlife Management Board (NWMB or Board) with an opportunity to apply for standing at the Nunavut Planning Commission's public hearing on the draft Nunavut Land Use Plan.

Pursuant to Article 5 of the *Nunavut Land Claims Agreement*, the NWMB is a quasi-judicial tribunal with decision making responsibility, acting as the main instrument of wildlife management and the main regulator of access to wildlife in the Nunavut Settlement Area (NLCA Section 5.2.33). Among the NWMB's discretionary functions, the Board shall provide recommendations to the Nunavut Planning Commission with respect to planning in wildlife management zones and areas of high biological productivity (NLCA Section 5.2.34 (b)). Once approved, the Nunavut Land Use Plan will guide land use decisions across the territory, including those that could potentially impact sensitive wildlife habitats. As such, it is important, and in accordance with the *Nunavut Land Claims Agreement*, that the NWMB be given the opportunity to provide the Nunavut Planning Commission with recommendations during the draft Nunavut Land Use Plan public hearing process.

The draft Nunavut Land Use Plan includes land use designations to protect important wildlife habitat, including key migratory bird habitat sites, caribou habitat, polar bear denning areas, walrus haul-out sites and marine areas of importance. As a Board responsible for the management and protection of wildlife and wildlife habitat, the NVMB can provide the Nunavut Planning Commission with valuable information pertaining to these designations and other important Nunavut wildlife species. Therefore, the NVMB is requesting that its Chairperson, Mr. Ben Kovic, be granted standing at the Nunavut Planning Commission public hearing on the draft Nunavut Land Use Plan.
