## RE: NPC File # 149166 [MS FRAM The Northwest Passage - In the Wake of Great Explorers]

The following works and activities have been proposed in the above-noted project proposal:

Marine Based Tourism: Passenger cruise ship through the Northwest Passage. The 2019 program proposed
one Westbound voyage (19 - 31 August 2019), and one Eastbound voyage (31 August – 12 September 2019)
with up to 240 passengers and 80 crew members on board per voyage. Activities include sightseeing by ship,
Zodiac cruising, kayaking excursions and shore landings for activities such as guided interpretive walks, birdand nature-watching and hiking.

- 2. Modifications to the original: Addition of visits to Eclipse Sound, Radstock Bay, Coningham Bay, and the Prince Leopold Island Migratory Bird Sanctuary.
- 3. Associated NPC File No: 148834; Associated NIRB File No: 18TN035.
- 4. Location: Kitikmeot and Qikiqtani Region [Various locations along the Northwest Passage including visits to the communities of Pond Inlet, Gjøa Haven, and Cambridge Bay ]

The Nunavut Planning Commission (NPC) has completed its review of the above-noted project proposal. The NPC previously reviewed works and activities associated with the current proposal and a conformity determination issued June 4, 2018, which still applies. In addition, associated activities were previously screened by the Nunavut Impact Review Board, including two (2) voyages within the Qikiqtani and Kitikmeot regions with visits to wildlife and historic areas as well as visits to the communities of Pond Inlet, Gjoa Haven, and Cambridge Bay. (NIRB FILE NO.: 18TN035). It conforms to the North Baffin Regional Land Use Plan (NBRLUP). The proponent has undertaken to comply with the applicable conformity requirements of Appendix C, H, and I of the NBRLUP.

The above-noted project proposal is exempt from screening by the NIRB because the NPC is of the understanding that the inclusion of visits to Eclipse Sound, Radstock Bay, Coningham Bay, and the Prince Leopold Island Migratory Bird Sanctuary does not change the general scope of the original project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the Nunavut Agreement do not apply.

By way of this letter, the NPC is forwarding the project proposal to the regulatory authorities identified by the proponent. Project materials, including the applicable conformity requirements, are available at the following address:

The regulatory authorities to which this letter is addressed are responsible under the Nunavut Planning and Project Assessment Act (NUPPAA) to implement any of the applicable requirements by incorporating the requirements directly, or otherwise ensuring that they must be met, in the terms and conditions of any authorizations issued.

This conformity determination applies only to the above-noted project proposal as submitted. Proponents may not carry out projects and regulatory authorities may not issue licenses, permits, and other authorizations in respect of projects if a review by the NPC is required. Regulatory authorities may consult with the NPC to obtain recommendations on their duties to implement the existing land use plans prior to issuing licenses, permits and other authorizations under subsection 69(6) of the NUPPAA.
