



NUNAVUT PLANNING COMMISSION NOTICE OF EXTENSION OF KIVALLIQ REGIONAL PUBLIC HEARING ON 2021 DRAFT NUNAVUT LAND USE PLAN

Notice is given that the Nunavut Planning Commission (Commission) has scheduled an in person Regional Public Hearings in respect of the 2021 Draft Nunavut Land Use Plan (DNLUP). Please note that the Commission has decided that the Kivalliq regional public hearing will be extended to include 1 additional hearing day in Thompson, Manitoba for affected Dēnesuᓴᓴᓴᓴ communities in northern Manitoba and Saskatchewan. Participants can attend any of the regional hearings in person or virtually and are asked to confirm which hearing(s) they will attend by **September 30, 2021**, and must provide copies of their written comments, presentations, and questions to the Commission or other participants by **October 20, 2021**. All proceedings will be open to the public and media and will be conducted with simultaneous English-Inuktitut-French-Dēnesuᓴᓴᓴᓴ interpretation. Participants will be able to provide responses to submissions, additional comments, or further responses to questions within 40 days following the last hearing. Agendas for the regional public hearings will be distributed to participants in advance for comment.
