Re: Comments on the 2021 Draft Nunavut Land Use Plan (2021 DNLUP) and request for inclusion of the Anuri Project to Appendix A

Dear Mr. Savoy,

I support the goals and aspirations of a Nunavut Land Use Plan. The stated intention of land use planning to provide guidance and direct resource use and development requires foundational knowledge of these resources and the involvement of many stakeholders. It is not clear that this foundational knowledge compiled to date includes mineral resources (and advanced projects in particular).

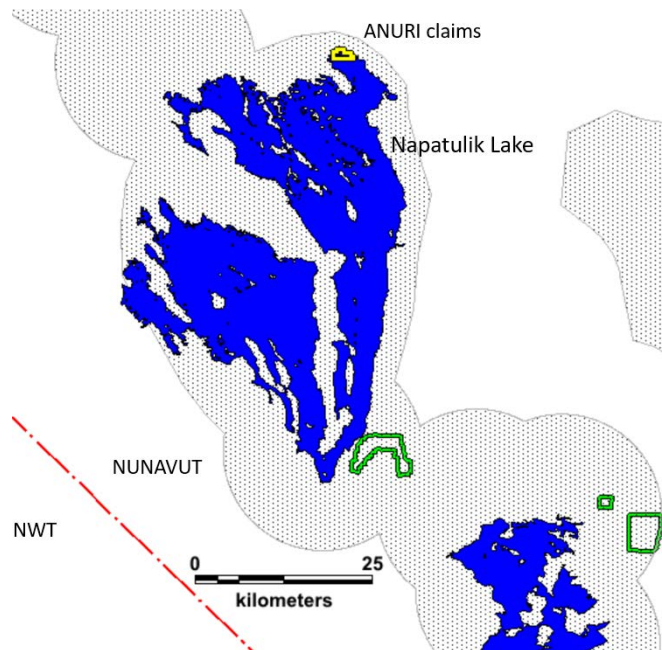
The 2021 Draft Nunavut Land Use Plan (2021 DNLUP) has granular detail including maps on wildlife resources such as migrating birds, caribou, polar bears, walrus, cod, and whales. I do not see a mineral resource map showing the location of known occurrences of diamonds or gold or soapstone for example. A proper **mineral resource inventory** is required for to make informed land use decisions for everyone. Mineral resources offer a tax base for the economic future of Nunavut as revenues pay for social services and infrastructure. Encouraging sustainable economic development is integral to the health of communities.

**Request for Anuri Claims to be included in Appendix A of the 2021 DNLUP**

All stakeholders have not been duly notified. As a sole proprietor single person company with Crown mineral claims I was surprised to hear of the recently announced 2021 DNLUP from others in the mineral exploration community but not through any government agency.

The advanced staged highly diamondiferous Anuri Kimberlite Complex is not listed in Appendix A of the current draft of the Nunavut Land Use Plan. As an existing mineral rights holder (100% owner) of the Anuri Claims (Anuri, Anuri East and Anuri 3) which cover the Anuri kimberlites I request that these claims be considered for inclusion. The claims are active as they were staked on January 31, 2021. No land use plan has been filed as no fieldwork was done this year (due to Covid and looking for involvement of another company to finance additional work). More than \$25 million dollars have been spent on the

historic property to date and quantities of gem quality diamonds have been recovered from the Anuri kimberlites.



The Anuri claims are currently within a 2021 DNLUP “limited use area” at the north edge of Napatulik Lake in the West Kitikmeot. The designation within the “limited use” zone is “Freshwater Caribou Crossings.”

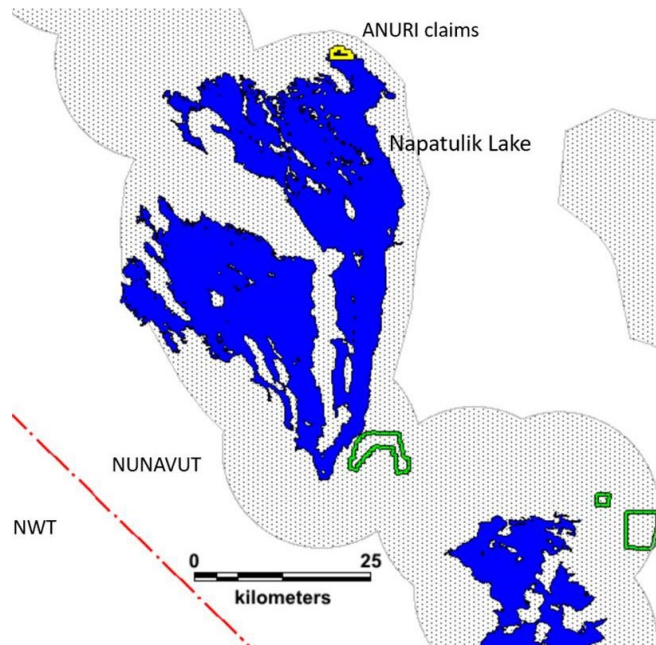
