As previously communicated, the Nunavut Planning Commission (Commission or NPC) has received additional funding to facilitate an information session with representatives of the Hamlets, Hunters and Trappers Organizations (HTOs) and other community organizations based in the Qikiqtaaluk (North/South Baffin) region in respect of the 2021 Draft Nunavut Land Use Plan (DNLUP) in advance of the Regional Public Hearings to be held in September-November 2022.
