1. Application for NWB authorization for use or deposit of water without a licence for a temporary pressure-washing station in Iqaluit. The estimated water use is a maximum of 20m³ cubic meters /day. Potential water sources include Dead Dog Lake and a creek going into the ocean on West-40 Road.
