2. NEXT STEPS

After receiving any responses to final written submissions by February 24, 2023 the record will close on the 2021 DNLUP. The Commission will then consider all feedback received on the 2021 DNLUP, including all written submission and oral comments provided during public hearings. A 2023 Recommended Nunavut Land Use Plan and fully revised Options and Recommendations document will be prepared and submitted to the Government of Canada, the Government of Nunavut, and Nunavut Tunngavik Inc. for consideration, and will also be made public.
